AN ACT TO AMEND THE APPROPRIATION ACT, No. 41 of 2014

BE it enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows:—

- 1. This Act may be cited as the Appropriation Short title. (Amendment) Act, No. 15 of 2015.
- 2. The First Schedule to the Appropriation Act, No. 41 of 2014 (hereinafter referred to as the "principal enactment") as amended by the Appropriation (Amendment) Act, No. 1 of 2015 is hereby repealed and the following Schedule is substituted therefor:—
