**AN ACT TO AMEND THE CODE OF CRIMINAL
PROCEDURE ACT, NO. 15 OF 1979**

BE it enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows :—

1. This Act may be cited as the Code of Criminal Procedure (Amendment) Act, No. 20 of 1995.

2. Section 303 of the Code of Criminal Procedure Act, No. 15 of 1979 (hereinafter referred to as the "principal enactment") is hereby amended in subsection (1) of that section by the substitution for the words "a term not exceeding two years for an offence may order", of the words "a term not exceeding two years, for an offence may, except in any case where the sentence of imprisonment imposed is a mandatory sentence of imprisonment order".

3. The First Schedule to the principal enactment is hereby amended as follows :—
