AN ACT TO AMEND THE SRI LANKA EX-SERVICEMEN'S ASSOCIATION LAW, NO. 8 OF 1976.

BE it enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows:—

1. This Act may be cited as the Sri Lanka Ex-Servicemen's Association (Amendment) Act, No. 42 of 1992.

Short title.

2. Section 3 of the Sri Lanka Ex-Servicemen's Association Law, No. 8 of 1976, (hereinafter referred to as the "principal enactment") is hereby amended as follows:—

Amendment of section 3 of Law No. 8 of 1976.

(1) in paragraph (e) of that section by the substitution for the words "affiliated to the Association; and", of the words "affiliated to the Association;"

(2) in paragraph (f) of that section by the substitution for the words "framed for that purpose.", of the words "framed for that purpose; and"; and

(3) by the addition immediately after paragraph (f) of that section, of the following new paragraph:—

"(g) to preserve the memory of the servicemen who sacrificed their lives in the defence of Sri Lanka."

3. Section 5 of the principal enactment is hereby amended as follows:—

Amendment of section 5 of the principal enactment.

(a) in subsection (1) of that section, by the substitution for the words "The Corporation may, by a vote of the majority of the members present and voting at a general meeting of the Corporation, make rules for", of the words "The General Council may, by a vote of two-thirds of the members present and voting at an annual meeting or a special meeting of the General Council make rules, not inconsistent with the provisions of this Act or any written law, for"; and

- (b) in subsection (2) of that section, by the substitution for the words "at a general meeting of the Corporation", of the words "at an annual meeting or a special meeting of the General Council".

4. The First Schedule to the principal enactment is hereby amended by the repeal of rule 27 thereof.
