CHAPTER 406

PILIYANDALA YOUNG MEN'S BUDDHIST ASSOCIATION

A LAW TO INCORPORATE THE PILIYANDALA YOUNG MEN'S BUDDHIST ASSOCIATION. Law No. 30 of 1976.

[21st December, 1976.]

Short title.

1. This Law may be cited as the Pilivandala Young Men's **Buddhist** Association Law.

Incorporation of the Piliyandala Young Men's Buddhist Association.

From and after the date of the 2 commencement of this Law the President, Vice-President, and members of the Committee of Management for the time being of the Piliyandala Young Men's Buddhist Association, and such and so many persons as now are members of the said Piliyandala Young Men's Buddhist Association (hereinafter referred to as " the Association") or shall hereafter he admitted members of the Corporation hereby constituted, shall be a body corporate (hereinafter referred to as "the Corporation") with perpetual succession under the style and name of the " Piliyandala Young Men's **Buddhist** Association ", and by that name shall and may sue and be sued in all courts, with full power and authority to have and use a common seal and alter the same at its pleasure.

General objects 3. The general objects for which the of the Corporation is constituted are hereby Corporation. declared to be-

- (a) the promotion of the study and propagation of Buddhism;
- (b) the encouragement of the practical observance of Buddhism;
- (c) the promotion of unity and cooperation amongst Buddhists;
- (d) the advancement of the physical, and intellectual development and culture of the Buddhists;
- (e) the engagement in social services;
- (f)representing and acting on behalf of the Buddhists in matters affecting them.

4. (1) The affairs of the Corporation Committee of Management. shall, subject to the rules in force for the being of the Corporation, time be a Committee administered by of Management, consisting of such number of persons to be elected in accordance with the rules in force for the time being of the Corporation.

(2) The first Committee of Management of the Corporation shall be the Committee of Management of the Association holding office on the date of commencement of this Law.

5. (1) It shall be lawful for the Rules of the Corporation, from time to time, at any general meeting of the members and by a majority of votes, to make rules for the admission, withdrawal, or expulsion of members; for the conduct of the duties of the Committee of Management and of the various officers, agents and servants of the Corporation; for the proceaure in the transaction of business; and otherwise generally for the management of the affairs of the Corporation and the accomplishment of its objects. Such rules when made may, at a like meeting, be altered, added to, amended, or cancelled, subject however to the requirements of subsection (2).

(2) No rule of the Corporation for the time being in force nor any rule which may hereafter be passed shall be altered, added to, amended or cancelled, except by a vote of two-thirds of the members present and voting at a general meeting of the Corporation, provided that such alteration, addition, amendment or cancellation shall have been previously approved by the Committee of Management.

(3) The rules of the Association in force on the date of commencement of this Law shall be deemed to be the rules of the Corporation made under this section.

Debts due by and payable to the Association.

6. All debts and liabilities of the Association existing at the time of the coming into operation of this Law shall be paid by the Corporation hereby constituted. and all debts due to and subscriptions and contributions payable to the Association shall be paid to the Corporation for the purpose of this Law.

How the seal of the Corporation is to be affixed.

7. The seal of the Corporation shall not be affixed to any instrument whatsoever except in the presence of two of the members of the Committee of Management. who shall sign their names to the instrument

in token of their presence, and such signing shall be independent of the signing of any person as a witness.

8. The Corporation shall be capable in Corporation law to take and hold any property, movable may hold or immovable, which may become vested in property, it by virtue of any purchase, grant, gift, immovable. testamentary disposition, or otherwise, and all such property shall be held by the Corporation for the purposes of this Law and subject to the rules in force for the time being of the Corporation, with full power to sell, mortgage, lease, exchange, or otherwise dispose of the same.

9. Nothing in this Law contained shall Saving of the prejudice or affect the rights of the rights of the Republic, or of any body politic or corporate, or of any other persons, except such as are mentioned in this Law.
